SCHOOL'S PURPOSE

As a ministry of Bible Baptist Church, Holden Beach Christian Academy is a safe learning environment for students.

Our facility allows the students to be in a class environment, around other children while still learning the curriculum at their own pace. Our church provides the facility, administration, and guidance in keeping records and assisting in education. Parents are expected to remain involved daily in their child's education. Our goal is to not only tutor each student academically, but also spiritually. We desire that the students develop a relationship with the Lord and strive to please Him in their actions, including their education.

ARTICLES OF FAITH

We believe the Bible to be the only inspired, infallible, authoritative Word of God. We believe that the King James Version is the preserved word of God for English speaking people. We believe that there is one God, eternally existent in the persons of the Father, Son, and Holy Ghost. We believe in the deity of the Lord Jesus Christ, in His virgin birth, in His sinless life, in His miracles, in His vicarious and atoning death through His shed blood on the cross, in His bodily resurrection, in His ascension to the right hand of the Father, His personal return in the rapture of the church and in power and great glory at His revelation.

We believe that, for the salvation of lost and sinful men, regeneration by the Holy Ghost is essential. We believe in the resurrection of both the saved and the lost: they that are

saved unto the resurrection of life; they that are lost unto the resurrection of damnation.

We believe in the spiritual unity of believers in our Lord Jesus Christ. We believe in the present ministry of the Holy Ghost, who is indwelling the believer, is enabled to live a godly life.

PREFACE

The primary purposes and objectives of HBCA are to train the student in the knowledge of God and the Christian Way of Life and to prepare the student for their entrance into life's vocation.

The primary responsibility of the teacher is the solemn realization that, under God, he or she is molding lives and character and is personally responsible for each student receiving a good foundation for the life ahead.

The parents must assume certain responsibilities in relation to their children. These would be in the area of providing for them the necessities of life: home, food, clothing; but most important is the spiritual and godly training in church, Sunday School, and in Christian School. We ask that the parents consider this as a privilege and give us their complete cooperation in relation to the classroom and in being sure their child is well behaved.

It is understood that attendance at HBCA is a privilege and not a right, which privilege may be forfeited by any student who does not conform to the standards and regulations of the institution, and that we may request the withdrawal of any student at any time who, in the opinion of the Administration, does not fit into the spirit of the institution, regardless of whether or not he/she conforms to the specific rules and regulations of this Christian School. For reenrolling students, the same standard applies. The Administration has the authority to accept or deny reenrolling attendees based upon past records and history of conformation to the rules and regulations of HBCA.

This handbook is filled with vital information regarding school policies and procedures. We suggest that parents and students review the contents together. If you have questions that remain unanswered after reading the handbook, please call or email the school office. We feel that open and clear communication between the school and the home is important to the success of our educational program.

ATTENDANCE

The Department of Nonpublic education suggests 180-day rule be enforced, except in cases of extended or chronic illnesses when certified by a physician and /or absences that are due to an emergency approved by the principal as excusable. At HBCA, the pastor sets the start and end dates as well as the holidays of each school year.

<u>Absences</u>

Each student is allowed ten (10) <u>lawful or unlawful</u> absences each school year. A <u>lawful</u> absence is defined by law for the following reasons:

 Illness or injury which prevents the student from being physically present.

- 2) Isolation required by health department.
- 3) Death of a member of the student's family.
- 4) Emergency or approved medical or dental appointment.
- 5) Required attendance at a legal hearing.
- 6) Religious Holidays.
- Approved school activity/educational opportunity.
- 8) Suspension for misconduct.

If the parent/guardian of the student/s *does not* notify the school about doctor's appointments, sickness, or any other situation that would be considered an "excused" absence, their absence will be logged as "unexcused."

How are lawful absences verified?

Parent notes and/or other verification are required for student absences and must be presented within 2 days of the student's return to school, otherwise the absence will be considered unlawful. The note MUST include: The student's name, the date(s) absent, the specific reason for the absence and the parent's signature. Appointments should scheduled for after school if possible. However, if a student must leave early for a scheduled appointment, the supervisor MUST be informed in writing at the beginning of the school day. If the supervisors are not notified about a student's absence, then it will automatically be logged as an unexcused absence. Only people on the student release form will be allowed to take a student from school. Medical verification is required for any chronic condition/illness likely to result in frequent absences. Once the parent's request in writing and the medical verification is received and approved by the Administrator/Principal, the student must make every effort to keep all schoolwork current. Excessive absences will inhibit the student's academic progress. Please have your child work in his/her PACE's while absent. Students, who do not complete the equivalent of a year's work (requirement varies) may be required to do school on breaks. If the student who has a chronic condition/illness does not maintain chronological status in their schoolwork, they are required to attend summer school to remain current in all schoolwork. A student must attend school for ½ the school day, or 3.5 hours to be counted present for the day. If a student is tardy three times and it is unexcused it equals one unexcused absence.

After the 10th absence has occurred:

The 11th, 12th, 13th, and 14th absence <u>MUST BE</u> <u>LAWFUL. NO EXCEPTIONS!!!!!</u>

The 11th, 12th, 13th, and 14th absence will be made up after school, hour for hour, **NO EXCEPTIONS!!!!** These absences are required to be lawful. If a student has unlawful absences after the 10th absence, they are considered truant and in violation of the NC State compulsory Attendance Law.

Upon the 15th absence, <u>whether lawful or unlawful</u>, a student is <u>required to attend summer school</u>, <u>NO EXCEPTIONS!!!</u> Day for Day missed. The summer school rate for <u>ALL</u> students (staff and members included) will be determined for each year.

The principal or a designee shall notify the parent, guardian, or custodian of his child's excessive absences after the child has accumulated three unexcused absences in a school year. After not more than six unexcused absences, the principal shall notify the parent, guardian, or custodian by mail that he may be in violation of the NC Compulsory

Attendance Law and may be prosecuted if the absences cannot be justified under the established attendance policies of the State and Local boards of Education. Once the parents are notified, the Administrator shall work with the child and his family to analyze the causes and determine steps, including adjustment of the school program or obtaining supplemental services, to eliminate the problem. The Pastor or Administrator may request that a law-enforcement officer accompany him if he believes that a home visit is necessary.

After 10 accumulated unexcused absences in a school year, the principal shall review any report or investigation prepared under G.S. 115C-381 and shall confer with the student and the student's parent, guardian, or custodian, is possible, to determine whether the parent, guardian, or custodian has received notification pursuant to this section and made a good faith effort to comply with the law. If the Administrator/Pastor determines that the parent, guardian, or custodian has not made a good faith effort to comply with the law, then the Administrator/Pastor shall notify the district attorney and the director of Social Services of the county where the child resides. If the Administrator/Pastor determines that the parent, guardian, or custodian has not made a good faith effort to comply with the law, the Administrator/Pastor may file a complaint with the juvenile court counselor pursuant to Chapter 7B of the General Statutes that the child is habitually absent from school without a valid excuse. Evidence that shows that the parents, guardians, or custodians were notified, and that the child has accumulated ten absences which cannot be justified under the established attendance policies of the local board shall establish a prima facie case that the child's parent, guardian, or custodian is responsible for the absences. Upon receiving notification by the Administrator/Pastor, the director of Social Services shall determine whether to undertake investigation under G.S. 7B-302. (1955, c.1372, art. 20, s.1; 1956, Ex. Sess., c.5; 1963, c 1223, s.6; 1969, c.339; c.799, s1; 1971, c846; 1975, c678, s.2; c. 731, s 3; 1979, c 847; 1981, c423, s. 1; 1985, c 297; 1991 (reg. CHURCH ATTENDANCE

As a Christian school, we believe attending church us of utmost importance and supports the foundation of our principles. Each student is **required** to attend at least **two** church services a week. If one does not have a ride, the bus ministry of Bible Baptist Church will be able to pick them up on Sunday mornings.

SECURITY

We desire to provide a safe environment for our students. Therefore, every school day at 8:30 a.m., the doors will be locked. Closed circuit television and a security system are enacted for protection. On breaks, the students will be able to play in designated areas to further protect them from any harm.

DEMERITS

Demerits are given to correct unacceptable acts or behaviors. Our school is not an institution for correction, but one of learning. If one demerit is issued, parents are asked to talk to their children to prevent further infraction/s. If two or more are given in one day, the parents are asked to discipline their

or

3 demerits = 30 minutes

4 demerits = 40 minutes

5 demerits = 50 minutes

6 demerits = 60 minutes

The supervisors have every right to assign any time amount of detention to the student committing the offence.

The parents are asked to discipline and talk to their child to avoid further issues. If a child does not want to be here and acts accordingly, parents will be asked to remove their child from the school. Received demerits will also disqualify any student from receiving privilege for that week, or loss of privilege. Any student that receives demerits consistently, parents will be asked to come in and counsel with the pastor.

DISCIPLINE

Discipline is necessary in a child's life. It is necessary to discipline to train a child efficiently. Teaching and learning are impossible without discipline. The method of discipline includes revoking of privileges for the day, extra work, and/or

loss of break time. If a child receives three demerits in one day, they will have earned immediate detention. A child that refuses to respond to our disciplinary measures and continues to be a disruption will be asked to withdraw.

A variety of disciplinary methods shall be utilized, which provide both positive and negative incentives. This is not a corrective institution; consequently, we ask that a child not be enrolled with the idea that he/she will be reformed. We are here to work with the home, but not to take the place of parents who have experienced difficulties fulfilling their roles.

All new students are admitted on probation for the first two weeks.

The student must always conduct himself or herself in a manner, becoming a lady or a gentleman. **GRIPING is not tolerated!** If your child does come home complaining about a policy or discipline, please follow this procedure.

- 1. Give the staff the benefit of the doubt.
- 2. Realize that your child's reporting is emotionally biased and may not include all the information.
- 3. Realize that the school has reasons for all the rules and are enforced without partiality.
- 4. Support the administration and call the school for all the facts.

When a child's attitude is not in accord with the schools' policies, the child will be warned, then given a demerit, if after three demerits are issued, they will be dismissed for the

day. A meeting may be called between the parents and pastor to help resolve any future problems. Children that refuse to follow the policies of the school will be expelled.

High school students in particular, because of their influence on the younger children, are trained to adhere to the school's philosophy and Biblically based program. Such adherence includes abstinence from homosexuality, watching pornography, smoking, use of alcoholic beverages, drugs, listening to worldly music, swearing, lying on social media (MUST be 13 years or older), viewing of worldly movies and television and all other questionable activities.

Students are reminded that God expects us to be disciplined in all areas of life:

Colossians 3:20 Children, obey *your* parents in all things: for this is well pleasing unto the Lord.

Romans 13:1 Let every soul be subject unto the higher powers. For there is no power but of God: the powers that be are ordained of God.

Hebrews 13:17 Obey them that have the rule over you and submit yourselves: for they watch for your souls, as they that must give account, that they may do it with joy, and not with grief: for that *is* unprofitable for you.

Proverbs 10:17 He *is in* the way of life that keepeth instruction: but he that refuseth reproof erreth.

Proverbs 19:18 Chasten thy son while there is hope, and let not thy soul spare for his crying.

Proverb 22:15 Foolishness *is* bound in the heart of a child; *but* the rod of correction shall drive it far from him.

CHAPEL

Each Thursday, we have a planned chapel program. This is a time of inspiration, devotion, and worship. Every student is required to attend all chapel services. Parents are welcome to attend any chapel services.

CONDUCT

The handbook is a general standard that should be used as a guide by all students. Not all acts of misconduct can be itemized. The following is an enumeration of the fundamental areas of conduct which may lead to disciplinary action such as detention, confiscation of material, revoking privileges, suspension, or expulsion.

General *apply even when not in school

- 1. Homosexuality, bisexuality, LGBTQ+, or any "lifestyle" that goes against the natural laws set by God.
- 2. Engaging in the use or possession of tobacco or the using, possessing, being under the influence, or

- dispensing of alcoholic beverages, narcotics, drugs, vaping, and/or other controlled substances
- 3. Using profanity, swearing, telling obscene jokes and stories
- 4. Fighting, causing, or attempting to injure anyone, threatening or intimidating others
- 5. Cheating, stealing, or destroying property
- 6. Immoral behavior, necking, petting, or holding hands
- 7. Possession of obscene material
- 8. Listening, playing, or singing of worldly music
- 9. Listening, playing, or watching worldly video games and movies
- 10. Disrespect of God, Bible, American Flag, government, or faculty and staff
- 11. Attendance at any place or event which may bring reproach on the name of Christ
- 12. Leaving campus without permission

The following objects are never to be brought to school: radios, tape or CD players, tapes, and CD's, mp3 players, electronic games, pagers, knives or razors, guns or play guns, weapons of any kind, fireworks, matches, cigarette lighters, cards, comics, magazines, or gum.

DETENTION

After school detention will be used for those students that have accumulated more than three in one week will be required to stay after school for 30 minutes or more on a date set by the supervisor. If a student fails to attend, time will be added for every time they miss. If it continues, they

will be dismissed from school permanently. During detention they will be required to clean or do work.

CLASSROOM

The classroom is a place of learning. Students are expected to respect the teachers. Students are to remain seated at their desks for the entire class unless they have permission to do otherwise. All paper or trash is to be kept off the floor. Note passing is also prohibited. Abuse of furniture and equipment will not be tolerated.

BATHROOM

The students are to ask permission to use the bathroom and are only allowed to go one at a time. This ensures the protection of each student's testimony and the proper care of the facility.

UNIFORMS

Direct links and details for the uniforms are located on our school website.

No other uniform will be permitted.

Extra Uniform Notes:

ONLY high school girls are allowed to wear **foundation or concealer** to cover blemishes.

NO eye makeup or lipstick permitted. If the supervisor finds any makeup excessive, the student will be asked to remove it.

Sloppy dressing and wrinkled clothing are not permitted.
Boys' hair is to be cut regularly, not allowing it to become long or full. Hair should be kept off the ears and the shirt collar and above the eyebrows. Sideburns are not to be below the ear lobe. No mustaches or beards are to be worn. Razor cuts that are bald on the sides or ribbed patterns on the sides or back are not allowed. Boys may wear modest amounts of jewelry; no earrings or any other type of facial piercings are allowed. No tattoos or face art.

The maximum number of earrings the girl students are allowed to wear is **one per ear**. Any other piercings must be removed. No toe rings, earrings, tongue, or face piercings. No tattoos or face art. No studded jewelry allowed. Hair color and styling must be neat, modest and within reason.

To protect each student, we ask that every student bathe regularly and wear deodorant!

 Any person leaving their vehicle to pick up a child or visit the school office should be modestly dressed to reflect the school guidelines.

LICE

"Students found with live head lice should be allowed to stay in the classroom for the remainder of the day, discreetly separated from peers, and referred to their parents for treatment. Students will not be allowed to attend school when lice (live bugs) or nits (eggs) are present. In addition, since school staff members may be unable to determine whether nits are dead after treatment, the presence of lice or nits requires that the student remain at home. Students are not to return to school until they have received treatment and all lice and nits have been removed from the child, as verified through re-screening by school staff."

(Excerpt from Brunswick County Schools <u>Policy Code</u> 4235/6135 addresses the presence of head lice and nits)

FIELD TRIPS

Field trips are an extension of the regular school day and are intended to be educational in nature. Students are expected to participate. Parents will be informed in advance of the nature and location of the planned field trip. Parents may be asked to assist, provided their schedule will allow it. The same level of discipline and the school dress code will be enforced during a trip. Students must qualify for the privilege to attend a field trip. They also may require additional money to pay for entrance or participation.

STUDENT CONVENTIONS

Every year, ACE hosts a convention for high school students to compete in different events and win medals. Events such as art, athletics, music, etc. The Regional Student Convention is held in Brevard, NC at the Wild's Camp; it is **mandatory** that the high school students participate and attend. A form will be sent home for parent consent; if a student "drops out," there will be a **fee** to cover the costs of holding that student's place.

The International Student Convention is the same as Regionals, but the only ones who would attend are the high school students who won medals at RSC. ISC is competing with other students from around the world. Finances for ISC will be earned through fundraisers.

A student must be enrolled for at least three months to compete in any of the Student Conventions.

FINANCES

- First child (\$140wk) = \$5,040.00/per year
- Second child (\$130wk) = \$4680.00/per year
- Third child (\$120wk) = \$4320.00/per year
- Fourth child (\$40wk) = \$3960.00/per year

If you pull your child for a given amount of time, you will still be required to pay for that week's tuition. The schoolbooks or paces are surcharged a nominal fee to help pay for shipping and building expenses associated with the school. Payment for paces will be due upon receiving the bill. Once a pace is

ordered for a student, the parent or guardian is required to pay for it, whether the student uses it.

There will be no refunds on PACEs. Paid school tuition may be refundable, depending on circumstances.

SCHOLARSHIPS

Holden Beach Christian Academy accepts/provides three different scholarships:

- Opportunity Scholarship: designed for children whose parents cannot afford a Christian school education. This scholarship is funded by the government and only applies to children who attended public school the year before enrolling into a Christian or private school.
- 2. BBC Scholarship: created for children who are regular attendees of Bible Baptist Church or a church of like faith. Children, such as bus kids, whose parents cannot afford a Christian education. If a child earns this scholarship, they are required to attend Bible Baptist Church at least two times a week.
- 3. Gene Junk Scholarship: created in memory of Gene Junk who faithfully attended Bible Baptist Church by riding the handicap bus. She lived her life in a wheelchair and was never able to complete her education due to her being born paralyzed. This is a scholarship of excellence to award HBCA students who show improvement in their academics.

FOOD/Lunch

Students are expected to bring their lunch each day. Ordering food from outside can be done per administration.

HEALTH SERVICES

Students who become ill during the school day will be given proper care or will be sent home. If a student must take prescription medication during the school day, the medicine, along with the doctor's directions must be brought to the administration as soon as the student arrives at school.

If your child should develop a contagious disease, please notify the school immediately. Do not send a child to school with a fever, diarrhea, or other symptoms of a contagious illness. The child should have a normal temperature for 24 hours before returning to school. No student with a temperature of one hundred degrees or above will be allowed to remain in school. Parents will be called to pick up the student at school.

HONOR ROLL

Students are honored for their academic achievements. Honor rolls are posted at the end of each grading period. Report cards and certificates will be awarded every nine weeks during a Sunday morning worship service.

A – Honor Roll 93-100 Straight "A's"

A/B Honor Roll 86-92 All A's and B's

A.C.E. curriculum is a mastery program. Every student must achieve at least 80% on a test before moving forward in a particular subject. If the student scores below 80%, administration will work with each student to help them achieve a passing grade. Completing the pace over is the last step taken for the student to retain the information.

PACES PROCEDURE

Each subject contains twelve PACEs. Every student is issued one PACE per subject. The student then sets a goal in each subject that should be completed by the end of the school day. If they are not finished, they will be issued a homework slip that a parent is required to sign and return it the following school day.

Within each PACE, the student will work up to a score grid, where they will raise their Christian flag to request permission to check/score the work they have completed. If their daily goal ends on a page without a score strip, the student is to check that day's goals anyway. If they have no mistakes, they will move on to complete more of their set goal. If they have gotten anything wrong, they will sit back down, correct the problem, and raise their flag to check/score again. Then, they will circle the PACE page number with a red pen notating that everything has been scored and corrected.

Throughout each PACE there are checkups, which are like quizzes and at the end of each PACE, there is a self-test. This prepares the students for the test and lets the teacher know if the student is ready to take the test.

When a student takes a test and passes with 80% or better, they are given a star for their progress star chart. They also receive a congratulations slip the following day during morning chapel. This is to encourage them and let the others student see the progress of their peers.

After a PACE is completed, the student is issued another PACE. Their test scores are recorded in the daily logbook and on their student progress report card.

CHORES

We desire to train each student to be responsible and to take initiative. Therefore, at the end of every school day, the students are asked to clean up after themselves. Chores rotate weekly and are to be completed or the student(s) will earn a demerit. These protocols are approved and follow the guidelines of the Christian Law Association.

HOMEWORK

Homework is to be done at home. If a student does not complete their homework, they earn a demerit. If a student is struggling to complete their homework and needs help, please contact their teacher. If they complete their

homework, please sign the slip in their homework folder and return it to the teacher. If they did not complete it, please write the teacher a note as to why they did not (if there was an emergency or important reason as to why); otherwise, do not sign the homework slip.

GRADUATION

For the high school students, there are four courses of study:

- 1. Honors
- 2. College Preparatory
- 3. General
- 4. Vocational

If a graduation date is set and the student fails to complete a Vocation Course of Study by that date, then they can choose to continue their schooling until it is complete/next graduation date or choose to accept a "Certificate of Attendance."

PHONE CALLS/ cell phones

Students are not allowed to make phone calls unless it is an emergency. The use of personal cell phones is also prohibited unless administration allows.

Students must turn in their phones to the supervisor as soon as they arrive at school.

SOCIAL MEDIA

Students 12 years old and younger are <u>NOT ALLOWED</u> to have any form of social media. Our job as a Christian school is to encourage honesty and support every parent/guardian in protecting their child/ren. We ask that the social media be deactivated immediately. Failure to comply could lead in expulsion.

Students who are 13 years old and older may have social media, but we highly recommend parents/guardians to do "social media checkups"; influences on the internet can influence a child's mood, attitude, focus, and functions. Please stay connected with the teachers if any of these concerns arise.

PRIVILEGE

Each student can earn three levels of privilege. The levels are A, C, and E. Earning privileges allows the students to do more than other students.

Earning **(A) privilege** allows the student to check/score their work without permission. It gives them 5 minutes of extra breaktime.

To earn **(A) privilege** the student must have no more than three demerits in the prior week. They must have enough academic stars (*received once a student passes the test in a pace*) and one Bible scripture memorized.

Earning **(C) privilege** allows the student to check/score their work, use the stapler/tape, get highlighters or pencils, use the

restroom without permission. It gives them 10 minutes of extra lunch time.

To earn **(C) privilege** the student must have no more than three demerits in the prior week. They must have enough academic stars (received once a student passes the test in a pace) and two Bible scriptures memorized. They also must complete either additional work at home that can be proven or a written report on any subject.

Earning **(E) privilege** allows the student to check/score their work, use the stapler/tape, get highlighters or pencils, use the restroom without permission. It gives them a 1-hour lunch break. They also can help other students at the direction of the supervisors. They can participate in off-campus activities. The student can also eat lunch off-campus or order food in.

To earn **(E) privilege** the student must have no more than three demerits in the prior week. They must have enough academic stars (received once a student passes the test in a pace) and three Bible scriptures memorized. They also must complete either additional work at home that can be proven or a written or oral report on any subject or topic selected by the supervisor.

REPORT CARDS

Report cards are issued four times each year to give students and parents an accurate indication of progress. Report cards will record grades and attendance for each 9-week period. Honor roll students will be recognized during a Sunday

Morning service with a certificate. Parents are required to sign and return the report card.

SCHOOL PLEDGES

Every school day will begin with prayer and the school pledges. The following are the three pledges used daily.

Bible

"I pledge allegiance to the Bible, God's Holy Word. I will make it a lamp unto my feet, a light unto my path, and will hide its Word in my heart, that I might not sin against God."

The Christian Flag

"I pledge allegiance to the Christian flag, and to the Savior for whose kingdom it stands. One Saviour, crucified, risen, and coming again with life and liberty for all who believe."

The American Flag

"I pledge allegiance to the flag of the United States of America and to the republic for which it stands, one nation under God, indivisible, with liberty and justice for all."

SCHOOL SUPPLIES

Each student needs to have these general supplies:

Personal KJV Bible

Pencils

Pencil sharpener

Notebooks

Highlighters

Erasers

Ruler

Tissue paper

Lunch daily

High school: calculator, protractor, and compass

PARENT ORIENTATION

Parent Orientation is mandatory for both parents and/or for the parent/guardian with legal custody. Failure to attend will result in the dismissal of the child/ren from Holden Beach Christian Academy. If there are conflicting schedules with the date set for Parent Orientation, the parents/guardians must notify the administrator or principal of the school beforehand and schedule a separate meeting.

PARENT-TEACHER MEETINGS

These meetings will be held quarterly to establish better communication between the school and the home. During PTA meetings, updates, school events, and/or issues that can be managed collectively will be discussed. Private PTA

meetings may be scheduled by the supervisors, administrator, or principal when needed.

WITHDRAWAL

A parent withdrawing a student from school must meet with the Pastor. The students' records will be given to the next school in which the child/ren are enrolled and not given to the parents directly unless specifically asked. The school retains no records of the students from year to year. Be sure to file your child's records in the proper place. It must be understood that although we are helping you educate your child, you are still responsible.
